# **2025 Northern Missouri Whitetail Archery Hunt Sweepstakes**

### **OFFICIAL RULES**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN TO LEGAL US RESIDENTS EXCLUDING FL AND NY. VOID WHERE PROHIBITED BY LAW. **ENTRY PERIOD:** The 2025 Northern Missouri Whitetail Archery Hunt Sweepstakes (the "Sweepstakes") begins on October 25, 2024 at 12:00 pm Eastern Time and ends on December 15, 2024 at 11:59 pm Eastern Time ("Sweepstakes Period"). Sponsor's time-keeping device is the official time-keeping device for this Sweepstakes.

**SPONSOR AND OPERATOR:** BeAlive, Inc., at 4400 James Savage Rd., Midland, Michigan, 48642 (the "Sponsor").

**ELIGIBILITY:** The Sweepstakes is open only to natural persons who are legal residents of the 50 United States, including the District of Columbia, and excluding Florida and New York, who are 18 years of age or older at entry ("Entrant"). If an in-person hearing is required, except as otherwise required by applicable AAA rules or applicable law, then it will take place in Midland, Michigan or other location determined by the Sponsor. The arbitrator will make a decision in writing, but need not provide a statement of reasons unless requested by either Party. The arbitrator must follow applicable law, and any award may be challenged if the arbitrator fails to do so. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the Dispute must be brought in a court of competent jurisdiction in Midland, Michigan. Sponsor agrees to pay the administrative and arbitrator's fees to conduct the arbitration (but specifically excluding any travel or other costs of Entrant to attend the arbitration hearing). If for any reason, a Dispute proceeds in court rather than arbitration, the Dispute shall be commenced or prosecuted in the state and federal courts located in Midland, Michigan and the Parties hereby consent to, and waive all defenses of lack of personal jurisdiction, and forum non conveniens with respect to venue and iurisdiction in such state and federal courts.

In no event shall any Dispute brought by either Party related in any way to the Sweepstakes be commenced more than one (1) year after the cause of action arose. If this provision is found to be illegal or unenforceable, then neither Party will elect to arbitrate any Dispute falling within that portion of this provision found to be illegal or unenforceable and such Dispute shall be decided by a court of competent jurisdiction within the courts listed for jurisdiction above, and the Parties

agree to submit to the personal jurisdiction of that court.

MISCELLANEOUS: The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
